THIS INCLUDES TRADITIONAL COMMUNICATIONS WORK SUCH AS MEDIA OUTREACH, CONTENT CREATION, RESEARCH AND STRATEGY DEVELOPMENT. CLIMATE AND ENERGY REMAINS THE LARGEST ISSUE SECTOR, COMPRISING ABOUT HALF OF THE BUDGET.
