Maine Inside Out offers theater workshops at Long Creek Youth Development Center, Maine's juvenile detention facility.

Our teaching artists work with incarcerated young men and women from every county in Maine to create and share original theater in the facility and also in communities around the state. In 2016 we had 62 participants in our programs at Long Creek. We shared 44 performances with more than 5,400 audience members, in communities from Biddeford to Bangor to Waldoboro. We also offer weekly theater groups in the three urban communities that currently send the most youth to Long Creek (Biddeford, Portland and Lewiston.) in 2016, 52 formerly incarcerated youth met weekly with Maine Inside Out facilitators to create and share new creative work, help plan and host our community events, and to mentor and support each other in times of challenging transitions. Youth involved with our "outside" programming often step into additional leadership roles by hosting and performing at our monthly open mics at Local Sprouts in Portland, or speaking alongside MIO facilitators at conferences, panel discussions or other public events.
