Part X, Line 2	The Credit Union is exempt, by statute, from federal and state income taxes on income related to its core purpose. The Credit Union pays tax on any unrelated business taxable income. The Credit Union had no significant tax liability for the year ended December 31, 2016. All income from the CUSO flows into the Credit Union and, as a result, is also tax exempt. ASC 740, Accounting for Uncertainty in Income Taxes prescribes a minimum recognition threshold and measurement methodology that a tax position taken or expected to be taken in a tax return is required to meet before being recognized in the financial statements. It also provides guidance for de-recognition, classification, interest and penalties, accounting in interim periods, disclosure, and transition. The Credit Union and its wholly-owned subsidiary are under regular audit by the tax authorities. The Credit Union believes that it has appropriate support for the positions taken on its tax returns and that its annual tax provision includes amounts sufficient to pay any assessments. Further, management believes that the Credit Union's tax-exempt status would be upheld in an examination. Nonetheless, the amounts ultimately paid, if any, upon resolution of the issues raised by the taxing authorities may differ materially from the amounts accrued for each year. The Credit Union and its CUSO file income tax returns in the United States federal and Colorado state jurisdictions. The Credit Union and its CUSO are no longer subject to income tax examinations for Colorado state income taxes before 2013 or for United States federal income taxes before 2013. The Credit Union classifies any interest on underpayments of income tax as 'Interest Expense', and classifies penalties in connection with underpayments of tax as 'Other Expense'.
