Conservation in Focus (1): A Voyage to Baja California and the Sea of Cortez in the Spirit of Ed Ricketts and John Steinbeck February 17-29, 2016 (Leaders: Dr. Geoff Hammerson & Audrey Benedict); Number of Participants-10 This seminar was conducted as a "classroom afloat" aboard the m/v Westward (owned and operated by Pacific Catalyst) and is based in Mexico. The trip re-explores the historic marine biology voyage conducted by Dr. Ed Ricketts and novelist John Steinbeck and emphasizes both the natural and cultural history of the Baja/Sea of Cortez region, a UNESCO World Heritage Site. We focus on current environmental impacts and conservation efforts in the Sea of Cortez related to global warming and to human pressures on marine resources.

In Darwin's Footsteps: Patagonia's Atlantic Coast, Los Glaceras National Park, Cape Horn & Tierra del Fuego (November 5-23, 2016) Leaders: Carol & Carlos Passera, Audrey Benedict and Dr. Geoff Hammerson (no honoraria paid); Number of Participants: 15 This seminar is both land and sea-based, tracing the route of Charles Darwin the HMS Beagle south along the Atlantic coastline to Tierra del Fuego and ending in southernmost Chile. We visit several of the sites that Darwin and Capt. Robert Fitzroy visited on their historic circumnavigation and scientific survey voyage. Darwin's scientific discoveries on that voyage would eventually lead to his discovery of natural selection and lay the groundwork for evolutionary theory. We read the entries logged in the Beagle's journals at the key sites visited by the expedition and discuss the current conservation and environmental challenges that the region faces due to global warming and human pressures on land and sea-based resources.
