Cultivating Philanthropy - WFCO is nurturing and growing an inclusive community of supporters who share the belief that when women and girls succeed, we all succeed. The Girls' Leadership Council (GLC), as part of WFCO's cultivation of philanthropy, develops 20 young women from across Colorado as agents of community change, through leadership and grantmaking. GLC Participants each design a community leadership project and as a group, they are guided in making decisions on grants totaling \$10,000 to nonprofit organizations supporting girls' high school graduation and STEM pipeline programming. Three young women participating in GLC are recognized for their leadership by receiving the Dottie Lamm Award, an academic stipend established in 1987 to honor Dottie Lamm's commitment to women's and girls' issues throughout the state, the Lockheed Martin STEM award to support their education, and the Black Fox Scholars award for their business and philanthropy leadership potential.
