The Foundation was organized in 1990 by the Lions members from both CO and WY to serve as the legal entity through which the Lion of both states could raise the funds needed by Lions to satisfy the commitment that both states had made to cover their commitment to provide 1/2 the cost to construct the new facility that now houses the Eye Institute on the Aurora campus of the C U Health Science Ctr, which facility was built & opened in 2001 then expanded in 2014. We continue providing additional equipment.

During 2016 the Fdn was primarily engaged in completion of the fund raising to satisfy our commitment to provide a total of \$1,314,650 to help the Univ of CO expand the physical building completed in 2001. Our new commitment was to cover the cost of 10 new examination lanes in the expanded RMLEI facility. Our fundraising plan was to apply for assistance from Lions Clubs Int'l Fdn. in Oakbrook, IL (LCIF) in providing matching funds to ours to satisfy our new commitment due to be paid over a three year period. Over the 3 yr period, we received a total of \$625,000 from LCIF. \$225,000 was received in 2015 and \$400,000 in 2016.

We also continued to provide funds to assist indigent patients in participating in the low vision examination and treatment program. \$1,625 was paid by our Foundation in 2016 on this program.

The Patient Assistance Program was established by our Foundation several years ago to permit Lions Clubs in Colorado and Wyoming to assist needy individuals with the cost they incur to travel to eye treatment doctors and programs. Our program requires a Lions Club to be responsible for and to provide some of the services and costs to transport the patients to the treatment facility and to account to us for the up to \$500 allowance for the travel costs that were incurred.
