HopeWest is a community-based organization that provides medical, emotional, psychosocial and bereavement support for people with serious illness and for their families. The comprehensive, expert and collaborative care profoundly changes each family's experience

Hospice Services - Hospice services focus on alleviating symptoms, relieving pain and making patients comfortable wherever they are - home, hospital, nursing home, assisted living facility or the HopeWest Hospice Care Center. More than 1,800 hospice patients were cared for in 2016. The generous support of the Western Slope allows us to meet the needs of our community.

4b (Code) (Expenses \$ 1,472,119 including grants of \$) (Revenue \$ 141,535)

In 2016 Grief Support Services-538 grieving adults found comfort through community support groups, individual counseling and small groups. Support services are also via monthly newsletters and phone calls. HopeWest Kids was there for more than 600 kids coping with the loss of a loved one thru programs like family-centered grief groups, Healing with Horses, school grief groups, summer camps, art therapy and much more. Palliative Care Services- 433 patients were served in our palliative care program, which provides inter disciplinary care focused on symptom relief and setting goals with each individual patient and family to assure the last part of a person's life is enriched, meaningful and comfortable. This program serves those with a life threatening illness, who do not qualify for hospice.

Retail Outlets - These businesses provide the communities we serve with a gathering place where they can get to know our organization and find support while coping with serious illness and grief. Heirlooms for Hospice, our three upscale resale shops, feature treasures donated by the community. The families of those HopeWest has served find comfort knowing that the treasures they donate to Heirlooms not only helps support HopeWest, but also bring joy to the neighbor who purchases them. Many volunteers in the stores find grief support in the work they do. Spoons bistro & bakery, our full service restaurant, and the Artful Cup, our coffee house and gift shop, are places known in the community as wholesome gathering spots for receiving information and support.

Volunteer Services - People with a passion for helping others make our work possible. 1,300 volunteers gave more than 81,000 hours of time in 2016, adding a value of 39 full time equivalents (FTEs). Gifts of time are as unique as those who contribute. Volunteers change our world by holding the hands of patients in need, providing art and music therapy to patients, supporting kids coping with grief, providing spiritual care, welcoming visitors, beautifying our gardens, creating a one-of-a-kind shopping experience at Heirlooms for Hospice, making our fundraising events special, baking cakes for patients' special celebrations and so much more.
