On 12/31/2016 there were 1157 families in the adoption process and 1506 children receiving post adoption services

 Childrens Charity Fund a restricted fund dedicated to humanitarian assistance to orphanages. The fund has been used to purchase food, clothing, diapers, formula, educational materials, toys, and medical assistance. The Childrens Charity Fund sponsors over 800 children awaiting adoption in Foster Care programs, orphanages, and the 7 Lily Orphan Care Centers in the Henan Province of China

 Family Development Services To ensure the success of the adoption, CCAI developed post adoption services designed to assist the families with the bonding process, cultural and interracial differences. Our Adopteen Program serves over 300 adopted American pre-teens and teenagers each year with Adoptteen hangouts, summer conferences and giving back trips where they spend time working and caring for children in the orphanages
