**The amount in Part I, Line 20 is comprised of the following:**

1. The credit card processing company that is used on the foundation's website charges a percentage fee on all credit card donations.

In 2016 donations by credit card were made through the foundation's website in the amount of \$6,485. Of this amount, the credit card processing company took a fee of \$194.37 and the foundation actually received \$6,290.63.

2. Donations to the foundation in the amount of \$200.00 were made in 2016 through an organization called FirstGiving. FirstGiving deducted from those donations administrative fees in the aggregate amount of \$25.00, so that the foundation actually received \$175.00.

3. The foundation received a donation in the amount of \$1,000 via wire transfer. The foundation was charged a wire transfer fee of \$12.00 in connection with that wire transfer.

4. The foundation's net asset balance at the end of 2015 was \$41,499, but was inadvertently stated to be \$41,449 on the foundation's 2015 990-EZ federal tax return. The amount on Part I, Line 20 includes a \$50.00 component to account for this discrepancy.

5. On December 30, 2015, the foundation wrote a check in the amount of \$245.80 to Alliance Medical Supply. Unfortunately, the Alliance Medical Supply check was inadvertently sent to Option 1 Healthcare Solutions. Option 1 Healthcare Solutions cashed the Alliance Medical Supply check that had been sent to it, even though the check was payable to Alliance Medical Supply. In January 2016, Option 1 Healthcare Solutions sent the foundation a check in the amount of \$245.80 to reimburse the foundation for the check that Option 1 Healthcare Solutions should not have cashed. Based on the foregoing, the \$245.80 check received from Option 1 Healthcare Solutions was deposited into the foundation's checking account but is not included above in the foundation's donations for 2016.

6. In February 2016 the foundation received a check in the amount of \$1,467.26 from Ascension Health Ministry. This amount was an overpayment that the foundation had made in August 2015 when it paid for medical care for a certain child. The medical care for that child turned out to cost less than previously invoiced to, and paid by, the foundation, so Ascension Health Ministry returned the amount of that overpayment to the foundation. Based on the foregoing, the \$1,467.26 check was deposited into the foundation's checking account but is not included above in the foundation's donations for 2016.
