CCALT assisted Colorado's ranchers and farmers in protecting their agricultural lands and encouraged continuing agricultural production by facilitating the creation of, holding, monitoring and defending conservation easements. The organization also consults with governmental agencies and others in the area of land conservation. CCALT had another productive year for land conservation in 2016, protecting 36,828 acres in 9 transactions. More important than the numbers is the positive impact our work is having in protecting rural communities, our ranching heritage and the spectacular working landscapes for which Colorado is known. See Schedule O for continuation (continued). The Colorado Cattlemen's Agricultural Land Trust takes pride in our 22-year record of fiscal responsibility and organizational growth. In 2016, CCALT accepted conservation easements valued at approximately \$16.7 million. As a non-profit organization, it is critical to be effective stewards of charitable donations and public conservation funding. CCALT prides itself on our fiscal conservatism and our return on investment. In 2016, CCALT protected conservation easements on an operating budget of approximately \$818,000. CCALT has protected approximately 500,689 acres from 1995 to 2016. We are proud of this accomplishment and are thankful for the generous support of our landowners, donors and partners.

Part II, Line 3	CCALT amended 5 conservation easements in 2016. Four were to correct scrivener's errors in legal descriptions as well as to correct the description of the water rights. Two of those four also amended the reserved building rights on the properties and two of the four also corrected the water rights tied to the deed of conservation easement. The final amendment also corrected the description of the water rights tied to the deed of conservation easement. All of the amendments followed CCALT's Amendment Policy, complied with section 170(h) of the United States Internal Revenue Code, and were consistent with Colorado Revised Statutes sections 38-30.5-101, et seq. CCALT did not release, extinguish, or terminate any conservation easements in 2016. CCALT completed 10 conservation easement transactions in 2016. One easement transaction was completed by transferring multiple easements held by another Colorado Land Trust to CCALT and consolidating them into one easement.

Part II, Line 5	The Colorado Cattlemen's Agricultural Land Trust (CCALT) is currently operating under a conservation easement stewardship, monitoring, and enforcement policy originally approved by the board in 1999 and renewed in 2016. Our policies ensure that CCALT will have the financial means necessary to continue our perpetual obligations to steward the conservation easements we have and will accept going forward. CCALT's policies and procedures also ensure that CCALT will have the necessary documentation to enforce each conservation easement going forward. This includes accurate baseline files as well as proper documentation of stewardship issues which have occurred in the past. Landowner requests or the land trust's response for interpretation or changes to the deed of easement must be documented in writing. Notice of the exercise of a reserved right must also be documented. If a property changes hands, it is CCALT's policy to update our records and discuss the conservation easement with the new landowner or representative to ensure that they fully understand the restrictions set forth on their property. CCALT has a policy of monitoring every easement on an annual basis. Monitoring usually includes a visit to the property in person but may also include aerial or remote monitoring. CCALT's conflict of interest policy applies to the stewardship policy and no landowner may monitor their own property. Monitors of CCALT conservation easements will not make decisions in the field as to whether or not a situation is or is not a violation of the terms of the conservation easement. Instead, monitors will collect information on the item of concern. Upper level staff will then evaluate the findings. If it is determined that a violation has occurred, a course of action is set to correct the violation. It is the stated policy of CCALT to enforce all of the terms of our conservation easements. It is the intention of the organization to avoid litigation, if possible, in the enforcement of any violation of a conservation easement. However, legal action may be required and any legal action, including the filing of injunctions, on the part of CCALT requires the adoption of a resolution of the Board of Directors.

Part II, Line 9	The organization receives gifts of conservation easements and grants toward the purchase of conservation easements. The easements contain numerous restrictions over the use and development of land, which is not owned by the organization. The value of donated conservation easements is based on the appraised value as determined by an independent appraiser. Easements are recorded as revenue when received and an expense is recorded for an equal amount whether the conservation easement is held by the organization or transferred to an eligible entity. Grants received for the purchase of conservation easements are recorded as revenue and as a conservation easement expense when the easement is purchased. The value of easements is not reflected in the balance sheet because the easements have no economic value to the organization. The organization monitors activities on the land and enforces restrictions contained in both donated and purchased conservation easements. The organization holds 299 conservation easements covering approximately 500,689 acres in 44 counties throughout Colorado and parts of Wyoming and New Mexico.

Part V, Line 4	The Land Trust holds three endowment funds. The Stewardship Endowment Fund provides funding for the ongoing and perpetual stewardship responsibilities accepted by the Trust for the conservation easements it holds. Donations to and investment income earned on the Stewardship Endowment Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure, at which time they are released from restriction. The Operating Endowment Fund consists of a donor-established endowment in which funds could not be expended until the assets reached a specific value, which occurred during 2014. Donations to and investment income earned on the Operating Endowment Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure, at which time they are released from restriction to the general operating fund to cover a portion of the cost of ongoing land trust operations. The Ron and Kitty Boeddeker Peaks to Plains Conservation and Restoration Fund (the Boeddeker Fund) consists of a donor-established endowment to assist ranching families in placing conservation easements on their property. Contributions to and earnings on the Boeddeker Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure. The Land Trust is required to replenish the fund through mitigation payments and additional charitable contributions, with the understanding that the fund will contain at least \$100,000 at the end of each year.
