To provide a safe haven for abandoned, malnourished and impoverished children in northern Haiti. We currently serve over 5,000 children, 348 children in our three care facilities and school on the Williamson campus, 877+ students at the John Branchizio and Cite Soleil schools combined, and 6,000 children and elderly through our nutrition programs and clinics. Today, Mercy & Sharing employs over 200 Haitian nationals in jobs such as, teachers, doctors, nurses, therapists, "mothers" (continuous child care), building engineers, accountants, cooks, and cleaning staff
