THE BOULDER HOUSING COALITION IS A 501C3, COMMUNITY HOUSING ASSOCIATION THAT OWNS/MANAGES 3 PERMANENTLY AFFORDABLE RENTAL COOPERATIVES IN THE CITY OF BOULDER, COLORADO. THERE ARE 55 LOW INCOME RESIDENTS LIVING IN THESE PROPERTIES. THE MAJORITY OF THE RESIDENTS ARE MAKING BELOW 30% OF THE AREA MEDIAN INCOME. THE HOUSES WERE PURCHASED WITH THE HELP OF AFFORDABLE HOUSING GRANTS FROM THE CITY OF BOULDER AND BOULDER COUNTY. ALL OF THE BUILDINGS ARE OWNED IN PARTNERSHIP WITH BOULDER HOUSING PARTNERS. THIS PROVIDES A PROPERTY TAX EXEMPTION ON ALL OF THE PROPERTIES BY STATE STATUTE.
