Utility Assistance Silver Horizons helps low-income seniors pay their gas, electric, water, firewood and/or propane bills. Many of the seniors we assist have either past-due bills, or they have received disconnect notices. Most of our clients live on about \$900 per month. In 2016, Silver Horizons assisted more than 120 households with utility bills, with an average payment of \$150 per household Food Distribution Each month, Silver Horizons distributes food to almost 2,000 extremely low-income seniors. Last year, approximately Silver Horizons distributed more than 1,080,000 pounds of food (enough groceries for 900,000 meals), and received more than 21,600 food pantry visits Home Repair and Safety Modification Working alongside the Albuquerque Department of Senior Affairs, Silver Horizons provides materials and equipment for minor home repairs and safety modifications/retrofits Silver Horizons helps seniors remain in their homes by providing materials for wheelchair ramps, grab-bars, handrails, hand-held showers, rails around and raised toilet seats, shower and bath seats, bed rails, transfer benches, bedside commodes, seasonal servicing of swamp coolers and so much more. In 2016, Silver Horizons helped purchase enough materials to make more than 650 home repairs, and helped purchase enough materials for more than 300 home safety modifications
