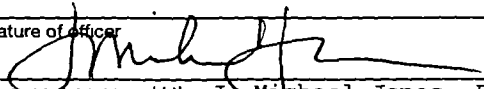
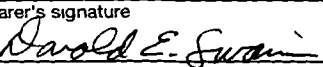

The directed distributions went to African Christian College Ed. and Ben As. (\$10,000) and Mountainside Church of Christ (\$26,504). The African Christian College Educational and Benevolent Association is a U.S. 501(c)(3) charitable organization.
