Downtown Artesia encompasses 40 city blocks and includes the Derrick Floor oilfield monument and the Oilfield Patch Plaza, with its grounds and fountain, and 4 other bronze monuments that are part of the History in Bronze series. The History in Bronze sculptures are located throughout the downtown area: Sallie Chisum is surrounded by brick pavers, a protective wall and bollards; Trail Boss has southwestern landscaping with numerous plantings and the Cattle Thief is located on a roundabout that includes landscaping and brickwork the Vaquero is surrounded by brickwork and boasts a bench for enjoying downtown The grounds of the new Artesia Public Library as well as the sculpture and landscape in the roundabout located at the intersection where the library is located are maintained by AMS since the library's completion in 2014. All bronze sculptures require periodic waxing as well as occasional patina touch-ups. Brickwork and walls require high-pressure washes to clean Streetscape of Artesia's downtown includes approximately 250 trees and numerous other plants and planters. Heritage Walkway contains 7 fountains that depict the culture of Artesia. All are made of handmade ceramic tiles. The floor of the Heritage Walkway is covered with a textured mural and the area contains many decorative trees and benches to enjoy the historic murals that adorn the walls. The expense listed covers maintenance and repair, security, electric and water, insurance and bronze care for these downtown improvements

DOWNTOWN EVENTS: Artesia MainStreet holds various events in the downtown area to draw the community into the area to explore, shop and socialize. 2016 events included the Main Event Car Show, Trick-or-Treat Main Street, two Art Walks, a Veterans' Day celebration and Christmas Downtown.

BAISH VETERANS' PARK: Artesia MainStreet teamed up with the City of Artesia to create a memorial to local veterans located in front of the Artesia City Hall. This beautiful monument to those who sacrificed for our freedom includes stainless steel panels that contain the name of the veteran, conflict during which they served and branch of service. The revenue listed is made up of application fees collected in order to verify all information submitted and help with engraving costs. The expenses are additional stainless steel panels and the fees associated with engraving the veterans' information. The park also includes brick pavers, a bronze monument and a tree stump carved into a bald eagle

downtown area. The series consists of the Trail Boss, the Vaquero and the Rustler. The three sculptures, using their informative plaques,

tell the history of the cattle industry in southeast New Mexico. The Freedom's Fire sculpture is located at Artesia's Baish Veterans' Park

where the names, dates and branches of service are listed for area veterans. The bronze at the new Artesia Public Library, located in the

roundabout in the street at the corner, is titled The Foundation, and features enormous renditions of the original first-copy hardbacks of

many classics, with children in various poses reading books. All sculptures are outdoor displays for the public, and there is no admission

or fee.
