Assistance League East Valley is a nonprofit organization that puts caring and commitment into action thru philanthropic programs such as "Adult Day Care Socials", scholarships to qualified students, new clothing items to victims of assault who are in crisis, distribute unused items donated to their thrift shop to other charitable organizations and provide two new outfits to students who have been identified by their school as children in need.

Line 4b:

Starbrite Foundation Inc. rescue children and young adults from human trafficking and provides emergency housing, crisis counseling and trauma recovery.

Part VI, Section A, Line 8a: Minutes of monthly meetings and the annual meeting are distributed to all board members and are available to the general public.
