In 2016, GCY celebrated its 18th year of service. Programs typically run from March through October. During that period in 2016, GCY facilitated 53 outdoor education programs river and land, serving 777 participants from across the country on 4,051 days in the outdoors, in one of our largest program seasons to date. Programs took place on seven sections of river in Utah, Colorado and Arizona, including Grand Canyon. The GCY program continues to be one of the most affordable programs of its kind, charging up to two-thirds less than commercial river trips. Participants paid only 50 of the actual cost of operating the programs in 2016 the rest was funded by grants, contributions and special events. Additionally, over 31,000 of financial aid was awarded to 92 participants during the year. Participants engaged in over 14,000 hours of community service during 2016, were required to earn a portion of the cost of their trip and be engaged in an educational project related to the cultural or natural history of the Southwest. continued below
