GACE alleviates poverty & advances gender equality through programs in health, education, fair trade & environment. Safe Births is our complete coverage of beneficiary pre-natal, delivery & postnatal maternal care at Togolese health clinics. School constructions, provision of eyeglasses to vision impaired, & distributing bicycles for transportation for secondary students, are some of our other projects. GACE has worked with beneficiary groups to plant 58,000 trees & is engaged in women's capacity building for development.

**Health:** GACE partnered with Project Cure to bring two 40' containers of maternal health and other new & used medical supplies to health clinics for the rural poor in Togo. New purchase value of the containers was over \$900,000 in medical supplies and equipment. GACE cleared the medical supplies through customs and delivered medical supplies to 30 clinics in Centrale and Maritime regions. Through its Safe Births program, GACE provided prenatal, delivery, and post natal care to 290 mothers who would otherwise have not had access to basic care for preventable diseases, infections, or other life-threatening birth risks. GACE midwife trainers work with participating clinics and beneficiaries to provide training in eradicating excision (Female Genital Mutilation) and improving nutrition, hygiene and sanitation daily practices.

**School Attendance:** During 2015-2016 GACE constructed 5 schools in Togo, West Africa, including desks & benches. Working with local community leaders, the schools were sited in areas where poor rural students were forced to travel long distances to attend elementary school or kindergarden. For secondary students, GACE has a different program to increase school retention. The Bicycles for Education program collects used and new bicycles in the United States for distribution to needy secondary students. We see a reversal of the dropout rate for secondary students enrolled in our Bicycles for Education program in areas where there are no buses and secondary schools can be up to a 9 mile walk each way for students.

**Eyeglasses for Vision Improvements:** GACE collected and shipped 10,727 pairs of donated eyeglasses, reading glasses and sunglasses to Togo, West Africa. Although it may be possible to access doctors for vision impairment evaluation, few can afford the cost of prescription eyeglasses, which can be over 4 months average wages. GACE provides lenses to eye clinics who can donate them to patients. In addition GACE distributes reading glasses and sunglasses in poor rural communities.
