Land ConservationVital Ground identifies crucial grizzly bear habitat on private land and works with willing landowners to protect the land's conservation values. This is accomplished through the voluntary placement of donated or purchased conservation easements on the land, or the outright fee purchase of land. Vital Ground has a perpetual responsibility to monitor the lands on which it holds conservation easements to ensure adherence to the terms of the conservation easements. Vital Ground has a responsibility to restore and manage the land it owns to provide quality habitat for the benefit of grizzly bears and other wildlife. In addition to developing and managing its own projects, Vital Ground occasionally provides grants to agencies, governmental entities and other nonprofit conservation organizations to assist with their efforts to conserve and restore important wildlife habitat, or to prevent conflicts between bears and people.

2016 Accomplishments Include Conservation Easements Monitored fifteen conservation easements in Montana, two conservation easements in Idaho and four Forest Legacy Program conservation easements in Idaho (all acquired prior to 2016). Continued working to advance the Selkirk-Purcell-Cabinet Linkage Initiative in northwestern Montana and North Idaho - an effort to conserve key grizzly bear habitat linkages between the Selkirk, Purcell and Cabinet - Yaak ecosystems. Continued working to advance the Swan Valley Grizzly Bear Conservation Initiative in Missoula and Lake Counties, Montana - an effort to conserve key grizzly bear habitat and linkages between the Bob Marshall Wilderness and Mission Mountains Wilderness areas.

Land Acquisition and Management Acquired one property totaling 43 acres in fee-title to permanently protect its wildlife habitat and scenic values and eliminate the potential for private development within the boundaries of the Lolo National Forest (September 15th, 2016). Provided a \$13,000 grant to Nature Conservancy, Canada to assist with the acquisition of a key 960-acre parcel of wildlife habitat that is critical to wildlife movements across the Rocky Mountain Trench north of Edgewater, British Columbia. Continued promoting the goals of the U.S. Forest Service's Community Forest and Open Space Program through intensive forest stewardship activities conducted on Vital Ground's Alvord Lake Community Forest. Monitored seven fee-title conservation properties in Idaho and three fee-title conservation properties in Montana (all acquired prior to 2016). Conducted habitat enhancement activities on properties held for the benefit of wildlife in Bonner and Boundary Counties, Idaho and in Lincoln and Missoula Counties, Montana.

Form 990, Part III, Line 4b:

Conservation Education Vital Ground provides information about grizzly bears, associated wildlife, and habitat conservation issues through its publications, special mailers, website, email communications, social media, live presentations, videos and other media opportunities. The organization also participates in collaborative educational programs to promote the conservation of grizzly bears and their habitat, minimize conflicts between bears and humans, and enhance the survival of grizzly bears.

2016 Accomplishments Include: Produced 10,000 copies of Vital News, the organization's biannual 16-page newsletter which reports on grizzly bear and wildlife habitat conservation issues, project opportunities, and accomplishments. Produced ten electronic newsletters that were distributed to approximately 4,400 unique recipients (44,000 total communications). These electronic newsletters reported on grizzly bear and wildlife habitat conservation issues, emerging project opportunities, conservation accomplishments, and funding needs. Produced other assorted postcards that reported on grizzly bear and wildlife habitat conservation issues, emerging project opportunities, conservation accomplishments, and funding needs. Maintained a website (www.vitalground.org) that provides comprehensive information to the public about grizzly bears, wildlife habitat conservation issues, current grizzly bear conservation challenges and project accomplishments. During 2016, the website received 231,000 page views by 101,000 unique visitors. Promoted wildlife habitat, grizzly bear natural history and conservation education topics to a social media audience of 23,000. Continued working to advance Vital Ground's grizzly bear conservation education partnership with the Chicago Zoological Society at the Brookfield Zoo's Great Bear Wilderness Exhibit. Conservation Education Grants Awarded (\$15,250): Vital Ground provided a \$10,000 grant to Wildlife Management Institute's Southwest Montana Bear Education Program to develop educational programs that will reduce bear-human conflicts west of Yellowstone National Park. Vital Ground provided a \$5,000 grant to Wildlife Media for an education and information video titled, "The Grizzly Returns," which explains grizzly augmentation efforts in northwest Montana and how it might help with the understanding of grizzly recovery in Washington's North Cascades. Awarded a \$250 grant to the Center for Large Landscape Conservation to help sponsor the 7th Annual Roundtable on the Crown of the Continent Conference. The conference focused on ways to sustain and enhance culture, community, and conservation.

Other: In addition to its land conservation and conservation education programs, Vital Ground also participates in research and management projects designed to promote the conservation of grizzly bears and their habitat, minimize conflicts between bears and humans, and/or enhance the survival of grizzly bears.

2016 Accomplishments Include: Vital Ground provided a \$7,000 grant to the Blackfoot Challenge Conservation Initiative to help enhance its Range Rider Program to prevent conflicts between large carnivores and livestock in the Blackfoot Watershed in Missoula and Powell Counties in Montana. Vital Ground provided a \$10,000 "Community Bear Aware" grant to the Swan Ecosystem Center to support its Swan Valley Bear Resources program. Vital Ground's contribution was used to continue a bear resistant-garbage container loaner program, assist landowners with small livestock to erect bear-proof electric fences, and allow SVBR's trained staff to engage with the public to share information about bears and bear safety in Missoula and Lake Counties in Montana. Vital Ground provided \$10,000 in grants to the city of Troy, Montana to help consolidate garbage containment and install electric fencing to prevent bears from accessing it. Vital Ground participated in a conservation partnership with AAA Sweetwater Drilling Inc. to dig a well to support Idaho Fish and Game's law enforcement activities and conservation efforts on and near a key Vital Ground holding in north Idaho.
