THE CLINIC ALSO SUPPORTS A VARIETY OF VISITING MEDICAL SPECIALISTS, INCLUDING CARDIOLOGY, GYNECOLOGY, INTEGRATIVE MEDICINE, NEUROLOGY, ONCOLOGY, PLASTIC SURGERY, AND PODIATRY. GRAND COUNTY HOSPICE, AN AFFILIATE OF MRH, PROVIDES COMPREHENSIVE END-OF-LIFE CARE FOR INDIVIDUALS IN THE AREA. HOSPICE STAFF PROVIDE IN-HOME MEDICAL AND PAIN MANAGEMENT CARE WITH THE GOAL OF HELPING PATIENTS MAINTAIN THE HIGHEST QUALITY OF LIFE POSSIBLE IN THEIR FINAL DAYS OF LIFE. ABSENCE OF THIS PROGRAM IN THE COMMUNITY WOULD CREATE A DIFFICULT SITUATION AT THE VERY TIME WHEN THESE SERVICES ARE MOST NEEDED. MOAB REGIONAL HOSPITAL'S ADDITIONAL PATIENT SERVICES INCLUDE INFUSION THERAPY SERVICES. UNDER THE DIRECTION OF LOCAL CHEMOTHERAPY CERTIFIED NURSES, AND WITH OVERSIGHT BY VISITING ONCOLOGISTS FROM GRAND JUNCTION, COLORADO, LOCAL AND REGIONAL CANCER PATIENTS ARE SPARED THE DIFFICULT EXPERIENCE OF HAVING TO DRIVE TWO TO FOUR HOURS ONE WAY TO A LARGE HOSPITAL FOR THEIR CHEMOTHERAPY AND OTHER INTRAVENOUS TREATMENTS. THIS ALSO ALLOWS THEM TO STAY IN THEIR OWN HOMES WHEN RECEIVING THERAPY. THE COMMUNITY HAS LAUDED THIS SERVICE AS A MOST WELCOME ADDITION TO THE HOSPITAL'S SERVICES.
