This would include but not be limited to, psychiatrists, psychologists, geneticists and scientists in areas pertinent to the discovery of the causes and treatment of psychiatric disorders. A reduced fee membership shall be available for students, early career investigators, and retired members. Criteria for eligibility for reduced fee memberships shall be defined by the Board of Directors in the ISPG Policy Manual and modified from time to time as the Board deems appropriate. Each member shall be entitled to one vote.
