EDUCATION - AFRICA FOUNDATION (USA) MAKES THE BUILDING AND IMPROVEMENT OF PRESCHOOLS, PRIMARY SCHOOLS, AND HIGH SCHOOLS A PRIORITY BELIEVING THAT THROUGH EDUCATION, RURAL PEOPLE CAN BREAK THE CYCLE OF POVERTY. FUNDS WERE DISTRIBUTED TO CLASSROOMS, KITCHENS AND FACILITIES PROJECTS IN SOUTH AFRICA (\$58,988), TANZANIA (\$117,627), BOTSWANA (\$33,087), KENYA (\$41,266), AND NAMIBIA (\$2,250).

AFRICA FOUNDATION (USA) HELPED FUND THE COMMUNITY LEADERS EDUCATION FUND (CLEF)(\$57,500). THIS BURSARY PROGRAM HAS THE GOAL OF EMPOWERING COMMUNITIES BY BUILDING LEADERSHIP AND ENABLING INDIVIDUALS TO REALIZE THEIR DREAMS. THE PROGRAM HAS TWO COMPONENTS, THE ACADEMIC SPONSORSHIP AND THE REQUIREMENT OF THE RECIPIENT THAT THEY SHARE THEIR NEWLY ACQUIRED KNOWLEDGE AND SKILLS WITH THEIR COMMUNITIES.

HEALTHCARE AND CLEAN WATER - AFRICA FOUNDATION (USA) BUILDS AND UPGRADES CLINICS AND ACCOMODATIONS FOR MEDICAL STAFF, BUILDS AND UPGRADES CRECHES FOR CHILDREN TO BE CARED FOR DURING THE WORK DAY, AND HELPS PROVIDE ACCESS TO CLEAN WATER.

IN 2016, FUNDS WERE DISTRIBUTED TO THE ZAMANI CRECHE (\$47,898) AND THE MATIMU CRECHE (\$46,503) TO BUILD ENVIROLOOS THAT HELP ELIMINATE PATHOGENS THAT COMMONLY SEEP INTO THE GROUND WATER.

FUNDS WERE ALSO DISTRIBUTED TO CLINICS TO BUILD NURSES' ACCOMODATIONS AND TO PURCHASE EQUIPMENT AND SUPPLIES.
