THESE DONATIONS ARE DELIVERED TO LARGE HUNGER RELIEF AGENCIES, INCLUDING MEND POVERTY, HEART OF COMPASSION AND DREAM CENTER. THESE AGENCIES THEN DISTRIBUTE THE PRODUCE TO SMALLER AGENCIES, DISPERSING FRUITS AND VEGETABLES TO HUNDREDS OF THOUSANDS OF SOUTHERN CALIFORNIANS EVERY MONTH.
