Ocean Noise: Oceans Initiative continued to carry out important marine conservation work to assess the impacts of ocean noise on whales, dolphins and fish. The results of this project were shared in various formats including scientific meetings, social media, public lectures, and meetings with stakeholders & marine wildlife managers. This work included working with partners at National Geographic's Pristine Seas project.

Dolphin Conservation: Oceans Initiative collected a record amount of photo-identification data on dolphins and spent much of the year analyzing those data. We expect the results of this project to inform conservation and management of pelagic dolphin (continued on Sch O)
