Son Glow Ministries, Inc, through its retail activities, minister physically and spiritually to individuals in the Surprise, Sun City, and Sun City West, Arizona communities. The boutique is a place where all are welcome to shop, seek prayer, assistance, and be refreshed in a loving and caring environment. Arts and Craft classes are offered for a nominal fee on a periodic basis.

Son Glow Ministries and other 501(c)(3) organizations in the area provide assistance to individuals seeking clothing and administrative assistance with job interviews or homelessness.

Some of the same individuals, along with customers of the boutique, also attend bible study and other classes held in the boutique after business hours.

The Boutique staff ministers to the downtrodden by paying for meals at restaurants nearby and pays for an occasional bus ticket to help stranded souls get home. The number of individuals assisted and the type of assistance provided is recorded on the Boutique's daily sales record on the day the assistance is provided.

Supported organizations are reputable organizations that are vetted by local churches, other charitable organizations, school counselors from the Peoria Unified School District, and/or referral by organizations with which Son Glow Ministries, Inc has developed a close working relationship. In some instances, members of the board of directors know the heads of the organizations personally and monitor the activities by observation/site visits e.g., Vida Ministries, Reba's Vision, and schools within the Peoria Unified School District.

These small random acts of kindness cost the ministry \$690.00 in FY 2016, however, incidentals previously listed on line 4d in prior years are now included in functional code 2016-003

Comment 2. Part V, Line 3b -a "No" check mark. The Ministry did not have any unrelated business gross income of \$1000 or more during the FY 2016 and was not required to file Form 990-T.

Comment 3. Part V, Line 13- -Son Glow Ministries, Inc. is not a Section 501(c)(29) qualified nonprofit health insurance issuer, therefore, no additional information about reserves required or on hand is provided.

Comment 11: Part XI, Line 9 - Other changes in net assets or fund balances. The method used by Son Glow Ministries, Inc. to pay the rent of the building housing Son Glow Boutique, the Ministry's retail store, is a bill pay service through a local bank. When the delivery date occurs on a weekend day, the bank adjusts the delivery date to the day before or day after the required date. In this instance, the bank paid the next month's rent the last business day in December and was treated as a prepaid expense.

Comment 12: Part XII, Line 3b - "No" response. Son Glow Ministries, Inc. did not receive a federal or state grant or award, therefore, no audit or audits were required. Had such an audit been required, Son Glow Ministries, Inc. would have contacted a professional accounting firm to perform the audit. The Son Glow Ministries, Inc. audit committee would review the findings in the audit report and implement action to remedy/correct negative practices.
