








Effective September 2016, the Credit Union entered into a deferred compensation agreement with certain executives that provides benefits payable to these employees if they remain employed by the Credit Union based on a cliff vesting schedule. If these employees become disabled, or at the time of death or change in control of employer, accrued benefits are immediately payable, however, the benefits are subject to forfeiture if employment is terminated for cause. The accrued liability related to this agreement was \$154,981 as of December 31, 2016.
