Depending on the particular conflict for employment conflicts, the credit union requires a notification to HR of any second jobs and approval by the employee's leader. For potential conflicts of employees working with relatives, the credit union requires a Senior Management approval before they hire, promote, or transfer anyone who might be working with a relative of a WSECUC employee. If the organization is notified of other types of conflicts, they deal with them as they arise, involving company leadership. Conflict questionnaires are signed annually by the board of directors. If a potential conflict is identified, it is reported to the board, which then reviews all information and determines if an actual conflict exists. Directors with the potential conflict recuse themselves from voting on any related issues. The organization's policy has assisted the credit union in prohibiting conflicts before they impact the company.
