WTA protects trails through grassroots advocacy on issues that impact hikers, such as trail funding and wilderness protection. WTA works closely with federal and state policymakers to advance hikers' interests in forest planning and new recreation projects. In 2016 WTA advocated for funding for national forests and parks, participated in trail and recreation planning efforts across the state and empowered more than 41,000 individuals to take action for trails with its online Trail Action Network.

WTA helped cultivate a community of hikers through outreach, our magazine (Washington Trails), our website (wta.org), and our mobile apps. Our online resources are free and open to the public, with trip reports filed every day by volunteers. 7,900 hikers filed more than 19,880 trip reports at wta.org in 2016. Our blog contains information on trail access, permit requirements, safety, and wildlife. WTA events bring hikers together at educational and social events across the state.

WTA expanded our programs that serve youth in 2016. Teachers and youth leaders received training and resources to support more than 1,376 outdoor experiences. WTA's gear lending library expanded so that youth groups can be properly equipped for their adventures year round. 63 school and community groups partnered with WTA for training and trail work.
