Daily games were offered such as Pinochle, Scrabble, Mexican Train, Pool, Darts, Wii Bowling, and Bridge. Health and wellness services took place weekly in the form of blood pressure checks, massage therapy, foot care, and seminars on wellness. Senior nutrition included daily meals from Greater Spokane County Meals on Wheels, Ethnic Lunches, Potlucks and Celebrity Chef Lunches. Other activities were offered including seminars, Book Club, Hikers, AARP Driver's Training, Stretch & Tone and Minstrels.
