 Social Change Program In 2016, 1,130 community members increased their knowledge about domestic violence and where to turn for help through our community education and outreach efforts. 703 youth learned about healthy relationships and the warning signs of abuse through our prevention education efforts. 175 community volunteers provided over 4,100 hours of service through involvement in New Beginnings' education and outreach programs, survivor support services and organizational governance. Home Safe Program Additionally, in 2016 New Beginnings began preparations for a re-design of our housing services which will focus on continued temporary housing for survivors fleeing abuse, rapid re-housing and homelessness prevention services.
