Adult day services, Full Life Care provided adult day health care to over 1,400 frail elders and adults with disabilities at 4 locations in King and Snohomish counties. Services included skilled nursing, rehabilitative therapy, and social programs which helped persons with chronic health conditions such as stroke, dementia, acquired brain injury, and development disabilities avoid life in a nursing home or other institutional setting. These adult day health programs provided respite to hundreds of family care givers.

4b (Code: 623990) (Expenses \$ 1153013. including grants of \$) (Revenue \$ 1303855.)

Two dementia care homes, Gaffney House and Buchanan Place, providing specialized dementia care to more than 26 long term residents annually.

Home care services, Full Life Care provided in home care services to hundreds of clients with over 300 home care aides. This service allows the client to remain in their home for as long as possible and avoid institutional care or the risk of homelessness.
