Providence St Peter Hospital offers a wide range of services that provide health benefits to the uninsured and underserved in Southwest Washington community. These services, many of which do not generate enough income to support themselves, include programs such as psychiatry, chemical dependency, a sexual assault clinic, and a pediatrics division, free and low-cost health screenings and education events, support services for cancer patients, survivors and their families, and medical training, research and career development for current and future medical professionals. Providence St Peter Foundation supports these services by developing and providing philanthropic resources from the generous individuals and businesses within the community. The Foundation was also able to provide over \$100,000 to fund animal-assisted therapy, music therapy for patients, support for the No One Dies Alone program, and assistance to employees facing financial hardships. The Foundation also supported various improvements throughout the hospital, such as the purchase of exercise and physical rehabilitation equipment, maternity supplies, and sweatshirts and sweatpants for patients. The Sexual Assault Clinic is part of Providence St Peter Hospital in Olympia. It serves residents of Thurston, Lewis, Mason, Grays Harbor, Pacific and Wahkiakum counties. The physicians, nurse practitioners, nurses and social workers provided special medical evaluations for children, adolescents and adults. Patients and their families are then referred to community agencies for counseling and other services. The Sexual Assault Clinic is a certified specialty services provider. The Foundation provided more than \$200,000 to support these programs in 2016.

Support for capital projects The largest capital project funding in 2016 was for the remodel of Sunshine House, a hospitality house located on the campus of St. Peter Hospital for patients and family members from outside of the area. Sunshine House was first opened in the mid-1980s and has only received minor updates and repairs beyond the expansion of the building in the mid-1990s. Included in the upgrades, once complete, will be solar panels, new HVAC, flooring, furniture and other improvements to both the common areas and guest rooms. Among those improvements is free wi-fi for guests, previously unavailable.

MJCC provides sensitive, holistic care to meet the physical, spiritual, social and psychological needs of each patient. Funds provided by the Foundation supported the programs of this ministry.

Providence has a single fiduciary Board, with responsibility for financial oversight associated with fulfillment of the Providence Mission, developing system policies, protecting the assets entrusted to the organization and overseeing the strategic and operational affairs of Providence's legal entities. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its officers, including our senior executives. Salaries for senior executives are reviewed by the Providence St. Joseph Health Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Additionally, Providence's labor market continues to spread across health care and into general industry. Because of this, Providence also takes into consideration general industry for-profit market data, where applicable. Base salaries for Providence executives are generally targeted to the median level of the market, as identified by the independent consultant and reviewed with the Executive Compensation Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational goals for furthering Providence operating commitments and strategic objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate market practices. The Board's process for executive compensation fully complies with IRS standards and mirrors best practices. The Foundation Executive Director is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position. The related organization then establishes the individual rate of pay within the range based on relevant experience, skills and competencies. The rate offered to the Executive Dire
