Education, awareness and capacity building for snow leopard conservation We provided environmental educational, skills-training, and outreach to adults and children Over 1,300 children in snow leopard habitat took part in Nature Clubs-school-based environmental education curriculums implemented in over 60 schools in snow leopard habitat We took 400 children on eco-camps in the mountains in Mongolia and India Eco-camps are experiential and hands-on learning consisting of an introduction to the snow leopard, biodiversity and food web, biological adaptations of generalist and specialist species, climate change, understanding greenhouse effect, human interaction with wildlife In addition to children, we provided targeted skills-training to wildlife managers in snow leopard habitat We trained 14 ranger in Kyrgyzstan on improved wildlife law enforcement, and in Mongolia a total of 18 rangers from Tost, Noyon, Sevrei and Great Gobi Strictly Protected Area-A were trained on the principles of double observer surveys We also used mass media to raise awareness for snow leopard protection on a national level in Mongolia and published 3 stakeholder newsletters distributed to 28 SLE communities, 4 local administrative and 4 PAs

Research and monitoring of Snow Leopards and their environment In 2016, we continued our long-term snow leopard study in South Gobi, Mongolia to increase our understanding of snow leopard ecology, behavior, and habitat needs. This study includes GPS collaring/tracking, trap camera surveys, prey surveys, data collection related to snow leopard disease and disease transmission, and assessment of livestock grazing impacts on the health and abundance of wild prey. We also began testing methods to GPS collar wild ibex. In addition, we are expanding similar research in China, India, Kyrgyzstan, and Pakistan. We continued and collected data for a multi-country study of impacts of climate change on rangelands in snow leopard habitat, and prepared for snow leopard collaring in India.
