It had very few expenses and the majority of money spent went to grants for mycology research and education, consistent with its mission

statement. Recognizing this continuing pattern, early in 2017, the Foundation reorganized as a public charity that qualifies as a Type I

supporting organization.

A new organization, the Stuntz Mycology Fund, was established as the supported organization for 2017 and the future.
