Oasis programming includes a weekly peer support check-in, HIV prevention, healthy relationship, wellness, and health promotion activities and services, violence prevention and crime victim advocacy services, and youth leadership development. Oasis serves over 650 youth annually.

Pierce County AIDS Foundation's Prevention Department provides services to those populations most at risk for HIV acquisition in Pierce and Thurston County. The services provided are based on harm reduction and empowerment models.
