In 1997, PA received donations of common stock - a total of 188 shares in 1998 & 1999. The donor's tax basis in the shares is approximately \$44 and the market value of the shares @ 12/31/98 and 12/31/99 was \$11271 and \$29083. PA adopted the reporting method of carrying the asset at donor's tax basis. The asset was subject to restrictions: Generally, the stock may not be sold and the dividends must be accumulated for two years before that income can be used for unrestricted purposes. To 4/19/16 the dividends have been re-invested in the stock along with all interest; that has been the case since the stock donation. However, after four years of ending the fiscal year in the red and the organization's inability to fundraise enough to cover the debt (due to staffing and volunteer issues), PA decided to sell some stock in spring, 2016. 243 shares of GE stock (or approximately 1/4 of PA's holdings) were sold for \$7447. It is expected that PA will return to reporting its investment income at donor's tax basis of \$44.00 in the future. Line 4 reflects only interest a banks savings account.

Included were the Prunathon @Sky Nursery, Master Gardener & Seattle Tilth plant sales. 188 volunteers dedicated 388 hours to getting the word out. Cass Turnbull, PA Board President, is the organization's founder and the most knowledgable source for 90% of the information offered to the general public by PlantAmnesty. She is one of the primary instructors for all classes (PA also contracts to other pruner experts as class instructors) and educational activities which constitute the major portion of events offered to the general public in order to fulfill the organization's mission. Mrs. Turnbull is paid a flat fee p/month for her teaching, fundraising events, writing articles for the organization's newsletter and writing grants along with various committee activities. Her book is sold through PlantAmnesty along with literature she has authored. PA pruning techniques are now available on YouTube through Cass' efforts as well as the organization's free hand-outs and other information generated by her. Ms. Turnbull and various committees (consisting of professional gardeners and arborists) determine the public events the org will pursue (fair/festivals UFS in conjunction with the U of WA, tours, etc). Ms. Turnbull is paid as a contractor with an annual cap approved by the Board of Directors.
