EXHIBIT A

RESTATED ARTICLES OF INCORPORATION OF LIFE SCIENCE WASHINGTON a Washington Nonprofit Corporation

The undersigned President and Chief Executive Officer of the above Nonprofit Corporation, pursuant to the provisions of the Washington Nonprofit Corporation Act, RCW 24.03, *et seq.*, submits to the Secretary of State of the State of Washington the following Restated Articles of Incorporation (the "Articles") for filing, which correctly set forth without change the provisions of the articles of incorporation as amended and shall supersede the original articles of incorporation and all amendments thereto.

ARTICLE I

Name

The name of this corporation shall be Life Science Washington (hereinafter referred to as the "Corporation").

ARTICLE II

Duration

The Corporation shall have perpetual existence.

ARTICLE III

Purposes

The Corporation is organized as a professional association exclusively for educational and other exempt purposes as defined in Section 501(c)(6) of the Internal Revenue Code of 1986, as amended (the "Code"), including, but not limited to, advancing the State of Washington's life science research, development, commercialization and economic development through collaboration, policy advocacy, information, education, and member services.

ARTICLE IV

Powers

The Corporation shall have the power to do all lawful acts or things necessary, appropriate, or desirable to carry out, or in furtherance of its purpose and objective which are consistent with the Articles, the Washington Nonprofit Corporation Act, the Corporation's Bylaws, and Section 501(c)(6) of the Code.

ARTICLE V
Limitations

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons. The Corporation shall not conduct or carry on activities not permitted to be conducted or carried on by an organization exempt from federal income taxation under Section 501(c)(6) of the Code.

ARTICLE VI
Directors

The Corporation shall have at least one (1) director. The actual number of directors as well as the composition of the Corporation's Board of Directors (the "Board") will be established from time to time in accordance with the Corporation's Bylaws.

ARTICLE VII
Limitation on Director Liability

A director shall have no liability to the Corporation for monetary damages for conduct as a director, except for acts or omissions that involve intentional misconduct by the director, or for any transaction from which the director will personally receive a benefit in money, property or services to which the director is not legally entitled. If the Washington Nonprofit Corporation Act is hereafter amended to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director shall be eliminated or limited to the full extent permitted by the Washington Nonprofit Corporation Act, as so amended. Any repeal or modification of this Article shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification for or with respect to an act or omission of such director occurring prior to such repeal or modification.

ARTICLE VIII
Indemnification

To the fullest extent permitted by Washington law as now or hereafter in effect, the Corporation is authorized to indemnify any director or officer of the Corporation. The Board shall be entitled to determine the terms of such indemnification, including advance of expenses, and to give effect thereto through the Bylaws of the Corporation, approval of agreements, or by any other manner approved by the Board. Any amendment to or repeal of the Articles shall not adversely affect any right of a director or officer of the Corporation hereunder with respect to any right to indemnification that arises prior to such amendment or repeal.

ARTICLE IX
Amendment to Articles of Incorporation

Any provision in the Articles may be amended, altered, changed or repealed as provided in the Bylaws of the Corporation. Notwithstanding the foregoing, no amendment shall be valid if such amendment would result in articles impermissible for an organization exempt from federal income taxation under Section 501(c)(6) of the Code.

ARTICLE X
Bylaws

The internal affairs of the Corporation shall be regulated by the Corporation's Bylaws. The Bylaws may be amended as provided in the Bylaws of the Corporation.

ARTICLE XI
Dissolution

In the event of dissolution, the net assets of the Corporation shall be distributed only to an organization to be selected by the Board that would qualify for an exemption as an organization described in Section 501(c)(3) or Section 501(c)(6) of the Code.
