The Seattle Contract Bridge League is a 501(c)(7) corporation.

Our purpose is social and recreational. We organize and conduct duplicate bridge tournaments in King County, Washington.

We are local unit #448 of a North American organization, the American Contract Bridge League.

Our members pay a membership fee to our parent organization, which then forwards to our unit a portion of those fees.

We have reported on Line 1 the portion we receive.

Our tournaments (five or six a year) consist of competition in duplicate bridge.

While this is a card game, our tournaments are not "gaming events."

No money is wagered. The winners receive no cash, merchandise, or anything of monetary value.

Instead, they are awarded and accumulate "master points," which establish skill levels for a local and national rating system.

We charge an entry fee for participating in our tournaments.

We have reported the annual total of these entry fees on Line 2, as "Program Service Revenue."

On Line 8 we have reported the revenue we received in 2015 from a one-time rental of a trailer.

We own and use this trailer to haul equipment and supplies to and from our tournaments.

(No trailer rental in 2016)

We rent venues for our tournaments. We have reported the rentals, and the janitorial costs, on Line 14.

We print and distribute flyers for these tournaments.

We also publish a bi-monthly bulletin for our members.

We report the costs of publication on Line 15.

We incur a wide variety of other expenses.

The largest of these are the costs we incur for ACBL directors at our tournaments; hospitality expenses at tournaments;

and hauling equipment and supplies to and from the tournaments.

We have reported all of these expenses, and other smaller ones, on Line 16.

We made two grants in 2016, to support education of young people in learning and playing bridge. We report those grants on Line 10.
