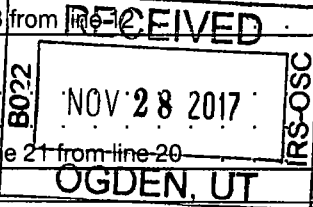

Since a number of decisions and applications regarding funding in the coming year were dependent on filing with the new name, our management was waiting confirmation, from our legal counsel, of the name change filing with the State of Washington to be able to append it to this document. The change and notification took several months longer than expected. Second, we changed to a business manager to one based in Canada in September. While the new business manager is quite familiar with Canadian systems, he assumed, wrongly, that the extended date for filing the 990 was the same as the extended date for filing the Canadian equivalent forms in Canada - a procedure he is very familiar with. So, while waiting for the confirmation of the name change from the State of Washington, he assumed he had extra time to file. Once he realized it was late he asked myself, the Director, to finalize the filing and provide the necessary statements for this late filing.
