RIVER COMMUNITIES Riverkeeper provides volunteers with the tools and training to monitor water quality and habitat health in their communities along the Columbia River and tributaries. Riverkeeper submits high-quality data to Oregon and Washington agencies to help guide cleanup and permitting decisions. Riverkeeper also conducts a dozen river clean-up events, reaching over 200 volunteers and removing over 5,000 pounds of trash from the water and the riverside. The River Communities project empowers citizens to get involved in the health of their local fishing and swimming locations. As the eyes and ears of the river, our volunteers take ownership for our regions livability through monitoring the rivers pollution levels. Riverkeeper also collects data on toxics in fish caught by local fishermen and releases the results to the public and media. In conjunction, Riverkeeper provides information to fishers on how to prepare fish to reduce the risk of toxic exposure. Riverkeeper works to restore our strong fishing and outdoor heritage by encouraging safe use. Riverkeeper utilizes old-fashioned community involvement plus smart technology to connect people to nature. For example, our smart-phone application Swim Guide connects families to the river by providing descriptions and directions to beaches, and real-time E. coli data for dozens of beaches. In addition, Riverkeeper volunteers utilize iNaturalist to share information from their Adopt-A-River sites with the public.

Form 990, Part III, Line 4b:

TOXICS REDUCTION Riverkeeper works to reduce the discharge of toxic pollution by identifying and stopping illegal pollution, reviewing pollution discharge permits, and advocating to state and federal agencies for better toxic reduction policies. Riverkeeper researches pollution violations and enforces that Clean Water Act against illegal discharges. In addition, Riverkeeper conducts monthly on-the-river patrols that discover and document illegal pollution and spills, establish a regular and visible presence to deter illegal pollution, collect water quality samples, and conduct outreach with river users. Riverkeepers action results in less toxic pollution, better treatment or control systems, and greater compliance with the law. Riverkeeper also reviews major pollution discharge permits on the Columbia River and submits detailed technical and legal comments to state agencies when appropriate. The comments advocate for pollution reduction and notify the agencies when the pollution permits violate the Clean Water Act. On the policy side, Riverkeeper works to ensure that federal and state water quality standards and implementation tools are strong enough to protect fish and wildlife, and all river users. Riverkeeper helped organize a coalition to reduce less toxic pollution in fish by asking Oregon and Washington to create more protective limits on toxics. Utilizing public pressure, grassroots organizing, and technical assessment of cleanup plans, Riverkeeper advocates for the thorough cleanup of the Hanford Nuclear Site, which is the most contaminated place in the western hemisphere. Riverkeeper produces action alerts and issue briefings on technical issues and upcoming decisions. Riverkeeper also organizes citizen attendance and testimony at multiple hearings regarding important Hanford clean-up decisions, including decisions on how to clean up leaking storage tanks containing high-level nuclear waste.

Form 990, Part III, Line 4c:

HABITAT PROTECTION AND RESTORATION Riverkeeper works to protect the Columbia River and river communities from the increasing threat of fossil fuel transport and shipping terminal development. The Columbia faces an unprecedented number of coal, oil, and natural gas terminals, which threaten aquatic ecosystems, public health, and our climate. Riverkeeper helped create a regional coalition called Power Past Coal to advocate against proposals to build new coal export terminals on the Columbia River and the Pacific Northwest. Coal companies propose to strip mine coal in Wyoming and Montana and ship it via trains and barges along the Columbia River Gorge to ports on the lower Columbia. Coal export infrastructure and ships would degrade our water quality and salmon habitat. If built, dozens of coal trains per day would impact Pacific Northwest communities. Coal contains toxic pollutants and when burned is a major contributor to harmful climate change. Working with allies, Riverkeeper helped defeat four of the six coal export terminals proposed. Riverkeeper helps organize tremendous public involvement in state and federal coal export permitting processes. Riverkeeper organizes thousands of residents along the coal train route to raise concerns to decision makers, turning coal export into a national issue regularly covered by regional and national media. Riverkeeper also presents to state and federal agencies the legal and policy reasons why coal export should be denied in Washington and Oregon. Riverkeeper also helps lead regional efforts to protect Columbia River salmon and public health from crude-by-rail proposals, which would send hundreds of thousands of barrels of Bakken crude or tar-sands-crude on trains to Columbia River ports, and then transferred onto ocean-going ships. One project, proposed by Tesoro Savage on the Columbia River, would send four to five crude oil trains per day, each 1.5-mile-long, from the Bakken Formation in North Dakota to the Port of Vancouver, Washington. The trains would cross hundreds of water bodies and travel for over 150 miles directly adjacent to the Columbia. Tesoro would store the oil in huge tanks along the river and then load the oil onto Panamax-sized oil tankers, which would sail through the Estuary and across the treacherous Columbia River bar. Riverkeeper pushes local and state decision makers to deny oil-by-rail proposals by presenting compelling technical and legal arguments on the public safety, economic, and environmental harm, and why the project does not comply with state regulations. Riverkeeper also leads the longstanding effort to protect the Columbia River Estuary from a proposed Liquefied Natural Gas terminal and pipelines that threatened to degrade key salmon habitat, as well as family farms and forestland. Riverkeeper works closely with impacted community groups, including farmers, fishermen, and landowners, as well as conservation groups.
