PEOPLE'S ACTION INSTITUTE. PAF engaged in discussions with the staff and board members of National People's Action and USAction Education Fund about the integration of program staff and campaigns to create greater capacity to achieve our shared goals. This work included facilitated staff meetings between all three organizations and ongoing board discussions between the three organizations which resulted in a restructuring of the three organizations to maximize our effectiveness. This process resulted in People's Action Institute (formerly National People's Action) becoming the center of shared program and campaign work.

4b (Code) (Expenses \$ 578,187 including grants of \$ 51,000) (Revenue \$ 23,210)

RESEARCH, EDUCATION, ENGAGEMENT, TRAINING. PAF supported community organizations in their efforts to educate the public about access to living wage jobs, the benefits of Medicaid expansion, ending racial health disparities, ending hunger, skyrocketing student debt, legal financial obligations & discriminatory local fines/fees that harm communities of color & other racial & economic justice issues. This education led to community engagement, including more than 120 actions, events & hearings across a range of issues, & a national event connecting over 200 people to share their experiences with debt & explore solutions. PAF conducted research & communications activities to support work on decarceration & economic issues in 16 states & DC. PAF produced a report as part of the annual Job Gap Economic Prosperity Series: Jobs After Jail (Feb 2016). We also produced a report on legal financial obligations (LFOs), Disenfranchised by Debt (Mar 2016). These reports highlight the barriers faced by people with conviction records to access good jobs, pay off LFOs & regain the vote. (cont Sched O)

FAIR WORK CENTER. In 2016, FWC collaborated with 7 community based organizations to present to over 9,000 workers about their rights. We launched the Fair Work Legal Clinic, a free legal clinic in partnership with the King County Bar Association, the University of Washington and Seattle University, which provided legal information and intake and referral services to over 250 individuals with potential violations at their workplace. We also began development of a health and safety training for low-wage workers to stay safe on the job and supported the launch of a mobile application that allows workers to talk with FWC anonymously or confidentially about their rights at work.
