Powerful Voices provides violence prevention and youth development activities to girls who are socialized and/or identifies as female, ages 12-18. Powerful Voices is focused on girls most impacted by oppression and violence. Powerful Voices also engages allies (adults and young men) who are interested in working in solidarity with girls to create a more just world. Our vision is for all girls to live healthy, personally meaningful lives in a society that values them.

 Community Engagement - Powerful Voices works within the community on girls' issues to promote equity and make the world a just place for everyone. Community Engagement efforts include producing the annual Girlvolution Conference, providing training on Powerful Voices curriculum and practices, serving on coalitions and partnering to provide outreach to girls detained in King County Juvenile Detention. In 2016, the Girlvolution Conference reached over 250 youth and adult allies (mentors) and served on three community coalitions. Powerful Voices trained 28 participants at nearly 20 different organizations to strengthen their girl justice analysis including exploring their relationship to privilege oppression, deconstructing messages imbedded in the socialization of girls in American culture, and learning how to become better adult allies to young people.

4b (Code) (Expenses \$ 108,554 including grants of \$) (Revenue \$)
 Case Management - Provides individual support to adolescent girls to help them meet their goals of service-learning, employment and education. A Case Manager meets regularly with youth to set goals, provide encouragement, support, information and referral services, and monitor progress towards accomplishment of goals.

4c (Code) (Expenses \$ 102,323 including grants of \$) (Revenue \$)
 Youth Employment Program - Provides girls with pre-employment, career building and other 21st century skills. Three cohorts of girls participated in a group employment program that includes individual goal setting and performance evaluation sessions. The first cohort is Develop Your Voice and Speak (DYVAS), where young women are employed to produce an alternate form of media to educate the community about social justice issues. The second cohort is ActiveVistas, where young women are employed to develop and present workshops at the Girlvolution Conference. The third cohort focused on developing job readiness skills through activities such as a career panel and mock interviews. The Youth Employment Program served 33 youth in 2016 referred through Seattle Youth Violence Prevention Initiative.
