THE DAKOTA SMILES PROGRAM IS A STATEWIDE PROGRAM TO PROVIDE RESTORATIVE AND PREVENTIVE DENTAL CARE TO UNDERSERVED CHILDREN ACROSS SOUTH DAKOTA. FOR THE YEAR ENDED DECEMBER 31, 2016, A TOTAL OF 3,833 CHILDREN WERE PROVIDED ORAL HEALTH CARE. OF THE 3,833 CHILDREN SERVICED, 2,159 WERE MEMBERS OF MEDICAID, 1,356 HAD NO DENTAL INSURANCE, AND 318 CHILDREN HAD PRIVATE DENTAL INSURANCE.

IN 2014 DELTA DENTAL WAS AWARDED A CMS GRANT TO PROVIDE DENTAL CARE ON SOUTH DAKOTA'S NINE INDIAN RESERVATIONS. THREE GROUPS ARE TARGETED - CHILDREN UNDER NINE YEARS OLD, PREGNANT WOMEN AND MOTHERS OF YOUNG CHILDREN, AND PEOPLE WITH DIABETES. THE PROGRAM SEEKS TO INCREASE PREVENTIVE DENTAL CARE INCLUDING CLEANINGS, DENTAL SEALANTS AND FLUORIDE VARNISHES, AND EDUCATE COMMUNITIES ABOUT ORAL HEALTH AND ITS RELATIONSHIP TO OVERALL HEALTH. FOR THE THREE YEAR GRANT YEAR ENDED JUNE 30, 2015, 7,824 PATIENTS WERE SEEN. THERE HAVE BEEN 11,038 FLUORIDE VARNISHES APPLIED, 10,043 CLEANINGS PROVIDED, 10,777 PATIENTS GIVEN ORAL HEALTH INSTRUCTIONS, 12,568 SEALANTS PLACED AND A VALUE OF CARE OF \$1,823,617. THE CMS GRANT ENDED 06/30/2015. THE FOUNDATION FOUND VALUE WITH THE PROGRAM AND DECIDED TO EXTEND THE SERVICES WITHOUT GRANT MONEY. IN 2016, 4,697 PATIENTS WERE SEEN. THERE WERE 5,339 FLUORIDE VARNISHES APPLIED, 4,555 CLEANINGS PROVIDED, 4,322 PATIENTS GIVEN ORAL HEALTH INSTRUCTIONS, 8,916 SEALANTS PLACED FOR A TOTAL VALUE OF CARE OF \$998,574 FOR WHICH THE DELTA DENTAL FOUNDATION ONLY RECEIVED \$336,991 IN COMPENSATING REVENUE FOR THE ABOVE SERVICES.
