YAKIMA TRIBUTARY ACCESS AND HABITAT PROGRAM (YTAHP) HAS THE GOAL OF INCREASING SAFE ACCESS OF SALMON TO TRIBUTARIES IN THE YAKIMA BASIN THAT THEY HISTORICALLY USED FOR SPAWNING. WE DO THIS BY WORKING WITH CONSERVATION ENTITIES ACROSS THE YAKIMA BASIN TO IDENTIFY AND PRIORITIZE PROJECTS THAT INCLUDE THE REMOVAL OR REPLACEMENT OF HUMAN MADE BARRIERS, SCREENING IRRIGATION DIVERSIONS AND IRRIGATION DIVERSION IMPROVEMENTS AND REMOVAL OR IMPROVEMENT OF OTHER PASSAGE OBSTACLES. THE MAJORITY OF OUR FUNDING GOES TO OUR PARTNERS TO IMPLEMENT CHOSEN PROJECTS, AS WELL AS USED FOR STAFF TO OBTAIN NECESSARY PERMITS, CONDUCT MONITORING, FACILITATE STRATEGIC PLANNING AND PROJECT REVIEW AND SUBMIT NECESSARY REPORTS AND OTHER ADMINISTRATIVE DUTIES. ANOTHER PRIMARY PURPOSE IS TO ASSIST FARMERS TO VOLUNTARILY IMPLEMENT BEST MANAGEMENT PRACTICES THAT BOTH IMPROVE CONDITIONS FOR SALMON AND PROMOTE WORKING LANDS.

Fire Adapt: The RC&D continued work implementing a grant the Bureau of Land Management to coordinate the Washington Fire Adapted Communities Learning Network (WA FAC LN). The grant covered expenses of WA FAC LN starting late November 2014. The WA FAC LN addresses Wildland Urban Interface issues, programs and assistance to connect and empower communities to create fire adapted communities and landscapes. In 2016, ten communities joined the network and were supported by sub-awards from this funding. The US Bureau of Land Management is supporting continued work for this project with a cooperative agreement. The communities implemented innovative fire adapted communities programs and shared what they learned throughout the network. RC&D will continue this project through 2017 into 2020.

DNR: Forest Resiliency Buring Pilot - House Bill 2928 that passed in Spring 2016 to explore the role of controlled burning in creating healthier, more fire-resilient forests in Washington State. Protecting communities and timber resources in putting fire to work. Starting in 2016 provide information on safely complete controll burns monitoring and tracking outcomes and making recommendations. Working with regional forest collaboratives and statewide prescribed fire group. Also, working with US Forest Service Pacific Wildland Fire Sciences Lab to coordinate and implement air quality, forest stand inventories, and assessments. In the Fall 2016, 15 prescribed fire project sites were identified by the forest collaboratives.

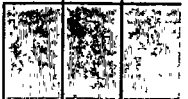
