In order to request the scholarship funds that are awarded, the contestants must fill out a request form and provide documentation statements and invoices from the school in which the contestant is enrolled. If the funds are to pay on a student loan, they need to provide a current bill from the institution which must show the account number, a copy of the promissory note showing the contestant as the primary or secondary payer of the loan along with an official transcript which shows the completion of the course work. Checks are made payable directly to the school or the lending institution.
