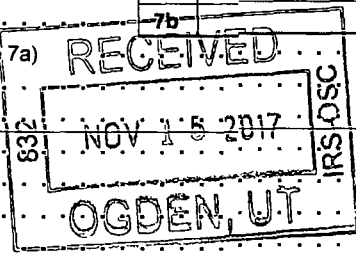

Form 990EZ, Part III, Line 28 Program Service Accomplishments:

OVCF convened the 3rd biennial Alliance for Leadership Programs (ALP) Conference. 71 individuals representing 38 Olympic Peninsula nonprofit organizations attended, plus another 30 guests and hosts. The presenter, Andy Robinson, was extremely well received, with attendees remarking that they gained confidence in asking for donations and felt more prepared to meeting the challenges of fundraising. Three special \$750 grant awards were presented for Excellence in Collaboration and Impact to Sequim Food Bank for establishing the Olympic Peninsula Healthy Communities Coalition, Rainforest Players in Forks for working with the City of Forks to rebuild the burned down Rainforest Arts Center, and to the Clallam County YMCA for working with the Sequim Aquatic Recreation Center (SARC) and Clallam County Commissioners to find solutions to re-open the SARC facility.

Form 990EZ, Part III, Line 29 Program Service Accomplishments:

OVCF acted as fiscal sponsor for the Port Angeles Theatre Project (PATP) to save the Lincoln Theatre. As such, OVCF wrote and submitted grant proposals on behalf of the project, and conducted direct mail appeal campaign segmented to individuals who pledged funds to support purchasing the theatre. Pledged funds were collected; however, another investor stepped in and purchased the theatre out from under PATP. OVCF then worked to

return donations in keeping with promises made to donors before OVCF became involved. Our successful management of this project has been lauded by the community. In our management of the donation refund project, we succeeded in inspiring donors to redesignate their gifts to OVCF or other community organizations of their choosing.
