Namibia Wildlife Sanctuary is located in Windhoek, Namibia. A main focus of NWS is a pro-active effort to reduce the conflict between local farmers, commercial vendors and wildlife, most especially big cats. In 2016 Namibia Wildlife Sanctuary introduced a program for collaring big cats intercepted in commercial areas. The collars will enable NWS to better follow the cats in hopes of heading off conflict as the cats approach commercial areas. In addition the NWS research team in collaboration with Wild Track, Duke University, and Manchester University developed a unique, non-invasive technique for identifying cheetah individuals from paw prints. Volunteers assist in all phases of the research for these projects and in the care of any animals in the rehabilitation program or permanent residence at NWS. Approximately 40 volunteers from the Lion Foundation assisted NWS in 2016.

The South African Foundation for the Conservation of Coastal Birds, SANCCOB, provides 24/7 service for sick and injured seabirds and abandoned chicks. They also respond to oil spill disasters along the South African coastline. SANCCOB has two locations in South Africa, Cape Town and Cape Francis. They employ 16 people full time and use many volunteers. SANCCOB treats over 2000 injured and sick seabirds a year, as well as run research projects in bird behavior and disease control. The volunteers from the Lion Foundation in 2016 were instrumental in saving 92 African penguins who were 'oiled' by an oil spill in the Easter Cape of South Africa. It took dedicated volunteers many hours to thoroughly wash, rinse and dry each bird and monitor them for weight gain, sufficient hydration and waterproofing prior to their release into the ocean.
