Unless previously barred by adjudication, consent or limitation, any claim against a trustee for breach of trust is barred as to any beneficiary who has received a final account or other statement fully disclosing the matter unless a proceeding to assert the claim is commenced within six (6) months after receipt of the final account or statement. In any event, and notwithstanding lack of full disclosure, a trustee who has issued a final account or statement received by the beneficiary and has informed the beneficiary of the location and availability of records for his examination is protected after three (3) years. A beneficiary is deemed to have received a final account or statement if, being an adult, it is received by him personally or if, being a minor or disabled person, it is received

Return of Capital Reclassification (ROCR)

If your portfolio is a trust, you may have been affected by a **Return of Capital Reclassification (ROCR)** included in this annual statement.
What is a Return of Capital Reclassification?

* Return of capital is the portion of a distribution that does not consist of dividends, interest or realized capital gains. For example, if a mutual fund pays \$1 in distributions but only makes 90 cents in interest, dividends and

capital gains on investments it sold during the year, the remaining 10 cents will be classified as Return on

Capital Reclassification (ROCR).

Annually, mutual fund companies review their previous year's activity to determine if a reclassification of income is required. This type of adjustment can occur with most any mutual fund - and may be processed any time during the following year. These adjustments may cause a portion of the income previously posted to the income portfolio of your trust account to be "reclassified," and that specific amount will be transferred from the income portfolio to the principal portfolio.

As for adjusting your tax records, ROCR is not *immediately* taxable. Instead, it is deducted from the Adjusted Cost Basis, which gives rise to a larger capital gain - or smaller capital loss - when the investment is ultimately sold. So, ROCR has potential tax effect only when the asset is sold.
