THE CLINIC'S MISSION IS TO PROVIDE CARE TO ALL, REGARDLESS OF ABILITY TO PAY, AND TO SPECIALIZE IN PROVIDING CARE FOR THE MEDICALLY UNDERSERVED, LOW INCOME, AND OTHER DISADVANTAGED POPULATIONS OF KODIAK ISLAND. THE CLINIC STRIVES TO IMPROVE THE OVERALL HEALTH OF THE GENERAL POPULATION THROUGH HEALTH EDUCATION AND PROMOTION ACTIVITIES, LIKE THE KODIAK ISLAND COMMUNITY-WIDE BIENNIAL COMMUNITY HEALTH FAIR. THE CLINIC'S PHILOSOPHY IS TO PROVIDE ACCESSIBLE, AFFORDABLE, COMPASSIONATE, QUALITY CARE SERVICES FOR KODIAK ISLAND. THE KCHC DENTAL PRACTICE OPENED ITS DOORS IN JUNE OF 2013. WE PROVIDE COMPREHENSIVE DENTAL SERVICES IN ALL ASPECTS OF PREVENTATIVE AND RESTORATIVE DENTAL CARE. (SEE SCHEDULE O FOR CONTINUATION) OUR INTEGRATED BEHAVIORAL HEALTH PROGRAM PROVIDES DAILY BRIEF INTERVENTIONS, MOTIVATIONAL INTERVIEWING STRATEGIES AND CONNECTIONS TO LONGER-TERM BEHAVIORAL HEALTH SERVICES FOR KCHC PATIENTS. THIS WORK IS CONDUCTED BY A LCSW WHO PLAYS A KEY PROVIDER ROLE ON OUR PRIMARY CARE TEAM. WE ACCEPT ALL INSURANCES, INCLUDING MEDICAID. ALL PATIENTS IN OUR DENTAL SERVICE ARE ELIGIBLE TO APPLY FOR OUR SLIDING FEE DISCOUNT PROGRAM TO ASSIST WITH THEIR DENTAL CARE BILLS. IN 2016, THE CLINIC PROVIDED MEDICAL CARE DURING 8,993 VISITS TO 2,728 PATIENTS, 1,011 DENTAL VISITS TO 408 PATIENTS, AND 713 BEHAVIORAL HEALTH VISITS TO 167 PATIENTS.
