Delphi Schools Inc develops, operates, and advises private, non-sectarian Delphi Academy schools owned and operated by Delphi Schools, Inc., and licenses the Delphi Program to schools owned and/or operated by other nonprofit tax-exempt organizations, in conjunction with Delphi Schools, Inc.'s Delphi Program comprised of its: (i) educational curriculum, syllabi, and supporting implementation advice for the education of students in preschool/kindergarten through high school and beyond, (ii) educational publications, and (iii) Delphi trademarks and service marks. Delphi Schools, Inc., currently owns and operates two such schools: a boarding school located in Sheridan, Oregon (The Delphian School), and a day school located in Los Angeles, California (Delphi Academy of Los Angeles). Delphi Schools Inc owned and operated a day school located in Santa Monica, California (Delphi Academy of Santa Monica) through June 2016 when the school was closed, and Delphi Academy of Campbell through May 9, 2016 when it was spun-off into its own nonprofit organization. Delphi Schools, Inc. also licenses three schools owned and/or operated by other nonprofit tax-exempt organizations: a day school located in Milton, Massachusetts (Delphi Academy of Boston), a day school located in Clearwater, Florida (Delphi Academy of Florida), and a day school located in Campbell, California (Delphi Academy of Campbell).
